## ANESTHESIA RULES FOR HIGH RISK PATIENTS AND PEDIATRIC PATIENTS

#### What to know:

§110.16 Sedation/Anesthesia of High Risk Patients and §110.17 Sedation/Anesthesia of Pediatric Patients

- Course completion can start now but not due until 1 Sept, 2019
- Make sure courses are endorsed by a provider identified in Rule §104.2 and meet the requirements listed in Rules §110.16 and §110.17
- TSBDE is not currently collecting course information

#### LICENSING NEWS

#### **Dental Assistant Registration Update**

Effective 9/1/2018: in addition to the current dental assistant registration application requirements, applicants will now need to have graduated from an accredited high school or, hold a certificate of high school equivalency, General Equivalency Diploma (GED), and submit fingerprints for the retrieval of criminal history information. Upon receipt of a completed application, instructions on how to schedule a fingerprint session will be emailed to the applicant.

#### **Staggered Renewals**

In order to align with recent rule changes, upon renewal of your license/registration your expiration date will be staggered to a biennial renewal affecting licensees due to renew by 10/31/2018 and thereafter. A system has been created in order to evenly distribute renewals to a two year license.

Licensees selected for a one year renewal will pay the one year renewal fee. Licensees selected for a two year renewal will be required to pay the two year renewal fee.

Renewal postcard reminders will continue to be sent out 60 days prior to your expiration date to the mailing address you provided.

#### **ANESTHESIA INSPECTIONS**

Pursuant to 22 Tex. Admin. Code § 110.18, regardless of issue date, all level 2, 3, and 4 permit holders will be subject to at least one inspection prior to September 1, 2022. All level 2, 3, and 4 permit holders who received their initial permit after March 1, 2018, must be inspected within a year of receiving their permit. TSBDE will begin conducting inspections October 2018.

### PRIMARY SOURCE VERIFICATION

Beginning January 1, 2019, the dental board will only accept an official final transcript as proof of completion for specialty training, or a course completion letter from the program director/chair.

#### DID YOU KNOW?

As a prerequisite to the biennial renewal of a dental or dental hygiene license the following are required:

Jurisprudence Assessment is required every four years and does not count towards continuing education hours for your license renewal.

24 hours of acceptable continuing education.

Approximately 5% of all licensees are randomly selected monthly for compliance with continuing education

You may now request a duplicate renewal certificate simply by logging on to your Online Licensing Account.
