LICENSING NEWS

Dental and Dental Hygiene Reminders: A dental applicant who takes an examination after January 1, 2019, must also successfully complete the periodontics and prosthodontics sections of a designated board approved regional examining board.

Each licensee shall complete the jurisprudence assessment every four (4) years. This requirement is in addition to the twenty-four (24) hours of continuing education required biennially for the renewal of a license.

Dental Assistant Registration:

A dental assistant must complete six (6) hours of continuing education each year in areas covering dental assistant duties. At least three (3) of these six (6) hours must be clinical continuing education.

Online License Renewals:

The processing of an online renewal is typically within one business day. If you searched your license and notice it has not been updated within the next business day, you may have one or more of the following deficiencies:

ANESTHESIA

Pursuant to 22 Tex. Admin. Code § 110.18 TSBDE is conducting Sedation and Anesthesia Compliance inspections. Failure to allow the inspection to take place may result in suspension in one or more of your permit(s).

Texas Dentists who hold a Level 2-4 Sedation Permit please ensure you have a current work address, phone number, and email on file with TSBDE. If you need to update your information, you may email the following information to anesthesiainfo@tsbde.texas.gov.

ANESTHESIA

DID YOU KNOW?

Effective 9/1/2019, a permit holder may not administer sedation/anesthesia under a level 2, level 3, or level 4 permit to a high-risk or pediatric patient unless the permit holder has completed the requirements outlined in Rules § \$110.16 and 110.17.

If you no longer use one or more of your permits and wish to have them removed from your record, please visit our website at http://www.tsbde.texas.gov under the Dentist Tab, Drop Level of Sedation. Please complete and submit a separate form for each level of sedation you wish to remove. You will receive a confirmation email once the permit is removed.

In regards to Moderate Sedation, Rule §110.5(c)(5)(c) states; Pulse-oximetry, heart rate, respiratory rate, and blood pressure must be continually monitored and documented at appropriate intervals of no more than ten (10) minutes, not just at the beginning and end of the sedation.

Sedation/Anesthesia of High-Risk
Patients (22 TAC § 110.16) and
Sedation/Anesthesia of Pediatric Patients
(22 TAC § 110.17) applications are now
available; please visit our website at
http://www.tsbde.texas.gov under the
Dentist Tab, Anesthesia Privileges.
Submit the application(s) along with proof
of education. Once your application has
been processed and approved, you will
receive an approval letter by mail.
The endorsements will be included on
your renewal certificate when
you next renew.

With recent legislative changes, an RDA who also holds a registration to monitor nitrous oxide will now begin to see this endorsement when they next renew their license. This endorsement will be located on the bottom left corner side of the renewal certificate.

AED pads have an expiration date! Please stop and take a moment to ensure YOUR AED pads have not expired.

The Bureau of Labor Statistics (BLS)
Occupational Outlook Handbook, is a
great resource for determining projected
employment growth (or lack thereof) in
the job market.

Though some of the current job sectors experiencing growth are the usual suspects like computing, engineering, and infrastructure professions, the medical profession is experiencing a strong positive outlook for future job prospects; especially in the dental professions.

According to the BLS, by 2026 job prospects for Dental Assistants and Dental Hygienists are projected to grow by 20% and will create an increased demand for those skilled positions in the market place. In fact, those two areas of dental practice are among the top 40 fastest growing jobs in the country. That is good news for the dental profession.

LICENSING INFO

American Association of Dental Boards (AADB) self-query report is no longer required to be submitted with any TSBDE application. We are working on updating this information on our website and forms. Your patience is appreciated.

Renewals continue to be staggered. A system has been created in order to evenly distribute renewals to be moved to a two year license. Licensees selected for a one year renewal will pay the one year renewal fee.

Licensees selected for a two year renewal will be required to pay the 2 year renewal fee. If your renewal was updated to reflect a one year renewal, when you next renew your license in 2020, it will be for 2 years. There is not an option to opt out. Renewal postcards will continue to be sent out 60 days prior to your expiration date to the mailing address on file.
