Dr. Burke thanked her committee members. Currently with one-year experience, registered or not, once they have passed the CODA coronal polishing 8-hour course, they can do coronal polishing. TDHA did not support the rule. TDA and TAPD sent comments late afternoon on 5/2/24 is creating barriers to practicing. The board wants to make sure they are not going against legislative intent. There is no evidence of patient harm to date. Ms. Studdard commented on the portion of "registered" creating workplace barriers. Ms. Lamb suggests "one year and CODA program completion or non-registered and two years of experience."

Dr. McNeill calls the question.

Ms. Palermo read the Sunset Commission 2.1 and stated: "requires one registration for dental assistants that perform: x-rays, pit and fissure, coronal polishing and nitrous oxide monitoring without being registered with the board." Dr. Burke commented about the limited availability of courses that the Dental Board requires.
