CEASE AND DESIST ORDER

On July 24, 2014, the Texas State Board of Dental Examiners ("Board") proposed this Cease and Desist Order against WESTWOOD DENTAL GROUP and individually against FARHAD ROOZBEH and L. DAWN DAVIS.

The Board has received information and possesses certain evidence indicating that FARHAD ROOZBEH and L. DAWN DAVIS (hereinafter as "Respondents") have violated provisions of the Dental Practice Act (the Act), codified at Tex. Occ. Code §§ 251 through 257.

Failure to file a written request for a hearing on this Order prior to September 15, 2014, will render this Order immediately effective and non-appealable in accordance with Tex. Occ. Code § 264.0525(b).

Pursuant to authority granted at Tex. Occ. Code § 264.0525, the Board finds and issues the following:

FINDINGS OF FACT

1. During the time period from May 1, 1989, through the present, Respondents practiced dentistry without a license and illegally owned Westwood Dental Group, including the dental practices at the following locations listed below. Respondents paid another dentist to use his dental license in order to operate the dental offices. Respondents also filed false documents with Texas Medicaid and Healthcare Partnership (TMHP) indicating that a dentist owns the practice. However, tax records and articles of incorporation indicate that Respondents own Westwood Dental Group.
