Join the Dental Review Panel

The Dental Review Panel was created in 2013 during the 83rd legislative session to review standard of care complaints and to determine whether the subject license holder has violated the applicable standard of care. Panel members typically review 1 – 4 cases per month and are compensated per case review. TSBDE is currently seeking prosthodontists. LICENSING

Delegation Reminder

During the November 2025 meeting, the Board emphasized the necessity for dentists and registered dental assistants to thoroughly review Chapter 114 to ensure that both parties understand what procedures may be delegated. A dentist is responsible for all delegated acts. If a dentist delegates a procedure to a registered dental assistant that they do not have the authority to perform- both parties may face disciplinary action.

Coronal Polishing

Friendly reminder that pursuant to TSBDE [rule 114.5](#), coronal polishing performed by a registered dental assistant may not be billed as a prophylaxis.

Fingerprint Renewal Requirement

All licensees lacking a State Identification (SID) number in the agency's licensing database will be mandated to undergo a fingerprint background check as a prerequisite for license renewal. An individual's State Identification Number (SID) serves as a unique identifier during background screenings, particularly for licensure and employment purposes.

Consequently, individuals licensed prior to 2016 may not have a SID number in the agency's licensure database. The absence of a SID number precludes the agency from receiving notifications regarding any criminal history events. Licensees lacking requisite fingerprint information will be notified by the Texas State Board of Dental Examiners ninety (90) days prior to license expiration. You will receive an email and mail notification.

The Board is authorized to request this information in accordance with rules 101.1(c)(6), 103.1(c)(10), and 114.2(b)(3), and Section 411.12504 of the Government Code, which permits the acquisition of fingerprints for criminal history background checks. TSBDE staff respectfully ask licensees to refrain from contacting the Board to verify the presence of their information in the database. 


Dr. David Yu presents Dr. Bryan Henderson with the presiding officer pin.
