**CEASE AND DESIST ORDER**

On February 12, 2020, the Texas State Board of Dental Examiners (Board) proposes this Cease and Desist Order (Order) against MIGUEL GUTIERREZ.

The Board has received information and possesses certain evidence indicating that Miguel Gutierrez has violated provisions of the Dental Practice Act (the Act), codified at Tex. Occ. Code §§ 251 through 257.

Failure to file a written request for a hearing on this Order prior to March 4, 2020, will render this Order immediately effective and non-appealable in accordance with Tex. Occ. Code § 264.0525(b).

Pursuant to authority granted at Tex. Occ. Code § 264.0525, the Board finds and issues the following:

**FINDINGS OF FACT**

On March 13, 2019, the Board received a complaint concerning the unlicensed practice of dentistry by Miguel Gutierrez. During the time period from June 10, 2017, through August 10, 2018, Miguel Gutierrez performed dental procedures on several individuals and billed Humana Insurance Company for dental procedures performed at 6101 Gateway West Blvd, Ste. #607-25, El Paso, Texas 79925 and 1155 N. Zaragoza Road, Ste. A104-171, El Paso, Texas 79907-1812, without holding a Texas dental license.


This conduct constitutes the unlicensed practice of dentistry, as defined by Tex. Occ. Code § 251.003, and is a violation of Tex. Occ. Code § 256.001 and may be subject to criminal prosecution.

**ORDER**

IT IS THEREFORE ORDERED THAT:

MIGUEL GUTIERREZ, **CEASE AND DESIST** from any further action in the state of Texas in connection with the unlicensed practice of dentistry.
