CEASE AND DESIST ORDER

On August 2, 2019, the Texas State Board of Dental Examiners (Board) proposes this Cease and Desist Order against JARVIS DENTAL LABORATORY.

The Board has received information and possesses certain evidence indicating that Respondent has violated provisions of the Dental Practice Act (the Act), codified at Tex. Occ. Code, Title 3, Subtitle D.

Failure to file a written request for a hearing on this Order prior to September 2, 2019, will render this Order immediately effective and non-appealable in accordance with Tex. Occ. Code § 264.0525(b).

Pursuant to authority granted under Tex. Occ. Code § 264.0525, the Board finds and issues the following:

FINDINGS OF FACT

1. During the time period from April 1984, through the present, Respondent operated a dental laboratory that performed dental laboratory services as defined in Tex. Occ. Code 266.001(3) in the state of Texas without applying for or obtaining a Board issued dental laboratory registration.
2. Respondent's operation of a dental laboratory in the State of Texas without obtaining registration is a violation of Tex. Occ. Code § 266.151 and may be subject to criminal prosecution.

ORDER

IT IS THEREFORE ORDERED THAT:

Respondent, **CEASE AND DESIST** from any further action in the state of Texas in connection with performing or offering to perform dental laboratory services for any person in the state of Texas until such time that Respondent is granted a dental laboratory registration by the Board.
