### **CEASE AND DESIST ORDER**

On September 2, 2025, the Texas State Board of Dental Examiners (Board) proposes this Cease and Desist Order (Order) against LEEANNE LANKFORD, RDH.

The Board has received information and possesses certain evidence indicating that Leeanne Lankford has violated provisions of the Dental Practice Act (the Act), codified at Tex. Occ. Code §§ 251 through 257

Failure to file a written request for a hearing on this Order by the 11<sup>th</sup> day after receipt will render this Order immediately effective and non-appealable in accordance with Tex. Occ. Code § 264.0525(b).

Pursuant to authority granted at Tex. Occ. Code § 264.0525, the Board finds and issues the following:

# **FINDINGS OF FACT**

- 1. During the time period from September 6, 2024, through the present, Leeanne Lankford, RDH, license no. 10592, whose license is currently in **CANCELLED** status, engaged in dishonorable conduct and engaged in the unlicensed practice of dental hygiene, without holding an active registered dental hygienist license.
- 2. Specifically, Leanne Lankford's registered dental hygienist number, 10592, was cancelled on December 31, 2013. Since that time, Leanne Lankford has continued to fraudulently work and provide patient care as a registered dental hygienist by forging fake licenses with expirations dated December 31, 2016; December 31, 2017; December 31, 2018; December 31, 2021; and December 31, 2024.
- 3. This conduct constitutes the unlicensed practice of dental hygiene and dishonorable conduct, as defined by Tex. Occ. Code § 262.002, and Tex. Admin. Code Title 22 §§ 115.9(2), (3), (5), and (8) and is a violation of Tex. Occ. Code § 256.052 and may be subject to criminal prosecution.

# **ORDER**

# IT IS THEREFORE ORDERED THAT:

LEEANNE LANKFORD, RDH, **CEASE AND DESIST** from any further action in the state of Texas in connection with the unlicensed practice of dental hygiene.
