CEASE AND DESIST ORDER

On July 29, 2022, the Texas State Board of Dental Examiners (Board) proposes this Cease and Desist Order (Order) against YUEDY LISETT CONTRERAS-DAVILA.

The Board has received information and possesses certain evidence indicating that Yuedy Lisett Contreras-Davila has violated provisions of the Dental Practice Act (the Act), codified at Tex. Occ. Code §§ 251 through 257.

Failure to file a written request for a hearing on this Order prior to August 18, 2022, will render this Order immediately effective and non-appealable in accordance with Tex. Occ. Code § 264.0525(b).

Pursuant to authority granted at Tex. Occ. Code § 264.0525, the Board finds and issues the following:

FINDINGS OF FACT

On March 1, 2022, the Board received a complaint concerning the unlicensed practice of dentistry by Yuedy Lisett Contreras-Davila. On or about February 7, 2022, Ms. Contreras-Davila questioned a confidential informant about his dental history, prepared the plaster for dental impressions, and assisted an individual take dental impressions of the confidential informant's upper and lower teeth at the location of 14126 Towneway Drive, Sugarland, Texas 77498, without holding a Texas dental license. After the dental treatment, Ms. Contreras-Davila was arrested by the Houston Police Department in conjunction with the Fort Bend Sheriff's Office.

This conduct constitutes the unlicensed practice of dentistry, as defined by Tex. Occ. Code § 251.003, and is a violation of Tex. Occ. Code §§ 256.001, 256.051, and may be subject to criminal prosecution.

ORDER

IT IS THEREFORE ORDERED THAT:

YUEDY LISETT CONTRERAS-DAVILA, **CEASE AND DESIST** from any further action in the state of Texas in connection with the unlicensed practice of dental hygiene.
