**CEASE AND DESIST ORDER**

On September 4, 2024, the Texas State Board of Dental Examiners (Board) proposes this Cease and Desist Order (Order) against BABBI VANORDEN, RDH.

The Board has received information and possesses certain evidence indicating that Babbi Vanorden has violated provisions of the Dental Practice Act (the Act), codified at Tex. Occ. Code §§ 251 through 257

Failure to file a written request for a hearing on this Order prior to October 4, 2024, will render this Order immediately effective and non-appealable in accordance with Tex. Occ. Code § 264.0525(b).

Pursuant to authority granted at Tex. Occ. Code § 264.0525, the Board finds and issues the following:

**FINDINGS OF FACT**

During the time period from October 3, 2023, through the present, Babbi Vanorden, RDH, committed dishonorable conduct. Specifically, Babbi Vanorden, RDH, is currently practicing dentistry outside the scope of her hygienist license and without the supervision of a dentist by soliciting and treating dental patients from her private residence. This conduct constitutes the unlicensed practice of dentistry, as defined by Tex. Occ. Code § 251.003, and is a violation of Tex. Occ. Code § 256.001 and may be subject to criminal prosecution.

**ORDER**

IT IS THEREFORE ORDERED THAT:

BABBI VANORDEN, RDH **CEASE AND DESIST** from any further action in the state of Texas in connection with the unlicensed practice of dentistry.
